## 4. Amisk Court Addition - RFD

Bennett Architects Inc. has completed a conceptual planning study, conceptual layout for the Amisk Court addition and has provided pricing for the next phase of architectural work to be completed. The next phase will include schematic design and building drawings.

The windows at Lakeview currently do not have window stops to regulate the opening of the windows, which is presenting safety issues at this time. All West Northern Glass has provided a quote to supply and install restrictor bars on all the windows.
